I would like to update you on the Department for Education's response to the coronavirus (COVID-19) outbreak between 22 September and 29 September.

## Skills and post-18 education

As you know, I strongly believe by driving up the skills base of a community we drive up what it will achieve. It is central to our mission of levelling up the nation and is vital if we want our country to grow economically and our productivity to improve.

On 29 September, the Prime Minister announced plans to transform the training and skills system, making it fit for the 21st century economy, and helping the country build back better from coronavirus (COVID-19) outbreak.

Adults without an A-Level or equivalent qualification will be offered a free, fully-funded college course – providing them with skills valued by employers, and the opportunity to study at a time and location that suits them. This offer will be available from April 2021 in England and will be paid for through the National Skills Fund. A full list of available courses will be set out shortly.

Higher education loans will also be made more flexible, allowing adults and young people to space out their study across their lifetimes, take more high-quality vocational courses in further education colleges and universities, and to support people to retrain for jobs of the future.

These reforms will be backed by continued investment in college buildings and facilities – including over £1.5 billion in capital funding. More details will be set out in

a further education white paper later this year.

Apprenticeship opportunities will also be increased, with more funding for SMEs taking on apprentices, and greater flexibility in how their training is structured – especially in sectors such as construction and creative industries where there are more varied employment patterns.

The government is also committing £8 million for digital skills boot camps, expanding successful pilots in Greater Manchester and the West Midlands and introducing programmes in four new locations. From next year, boot camps will be extended to sectors like construction and engineering, helping the country build back better and support our refreshed Industrial Strategy.

Earlier this year the government launched its free online Skills Toolkit, helping people train in digital and numeracy skills. This is being expanded today to include 62 additional courses.

£2.5 billion is also being made available through the National Skills Fund to help get people working again after COVID, as well as giving those in work the chance to train for higher-skilled, better-paid jobs.

## Use of the NHS COVID-19 app in schools and further education colleges

On 24 September, NHS Test and Trace launched the NHS COVID-19 app to help control the spread of coronavirus (COVID-19). The app will be available to download for anyone aged 16 and over which means that some students in year 11, students in years 12, 13 and in further education colleges will be eligible to use the app and benefit from its features.
